### **2026 FEE SCHEDULE**

#### **WATER CHARGES:**

Monthly Service Connection Fee: \$48.14

Contract Water Service (for local government agencies): \$1,820.23 annually

#### **Water Rates:**

Tier One: \$3.54 per 1,000 gallons (0-6,500 per month)

Tier Two: \$11.21 per 1,000 gallons (6,501-15,000 per month)

Tier Three: \$22.42 per 1,000 gallons (over 15,000 per month)

Delinquent Fee: \$30.00

Delinquent accounts are also subject to being charged interest at an annual rate of 18%.

#### **Turn Off/On Fee:**

\$50.00 (Monday-Friday, 8:00am-5:00pm)

\$120.00 (After hours, weekends, holidays)

Due to circumstances requiring additional work and equipment to turn on a shareholder meter such as but not limited to snow removal to gain access to the meter, a time and materials cost plus 15% (Administrative fee) will be charged at the discretion of the Manager).

**PLEASE NOTE: It is Company Policy that the Shareholder or a representative of the shareholder is required to be present when water service is turned on.**

#### **TRANSFER FEES:**

Share Transfer Fee: \$350.00

Shareholder Trust Conversion: \$150.00

#### **ASSESSMENT CHARGES:**

Annual Stock Assessment: \$350.00 per share

Delinquent Fee: (5%)

#### **MISCELLANEOUS CHARGES:**

New Service Connection Installation: \$4,000.00 - \$7,000.00 \*\*\*

Meter Tampering Fee: \$150.00

Lock Charge: \$30.00

Nonuse of Stop & Waste Valve Fine: \$250.00

Negligence/Wasting Water Penalty:

1<sup>st</sup> Violation: \$100.00

2<sup>nd</sup> Violation: \$200.00

3<sup>rd</sup> Violation: \$300.00 (plus \$100.00 for each violation in excess of three (3)).

#### **COURTESY SERVICES:**

**Water Shutoff for Repairs:** There is no turn off/on charge for those doing repairs to their property. Please remember that the water meter is Company property and only GVMWC personnel are authorized to handle the water meter.

**Seasonal Service Discontinuance:** To reduce water loss from freezing and broken plumbing, the Company will provide an annual turn-off/turn-on service at no charge for shareholders who do not require water service from October to April. At locations for which annual written requests for seasonal water service discontinuance will have the water turned off each year in October and resumed in the following month of April.
